A description of the efforts made by the LEA to meaningfully consult with its required community members and the opportunities provided by the LEA for public input in the development of the plan.

This plan was developed as a result of feedback from parents from surveys done before developing the 2021-24 LCAP and in September 2021. The electronic surveys were sent out on Parent Square. The school also received feedback during monthly Parent Council meetings on Zoom. Staff was also consulted during regular weekly meetings. Staff discussed the needs of their students after observing them in the classroom during the first few weeks of the 2021-22 school year. The school's special education coordinator was also consulted by the administrator.

A description of how the development of the plan was influenced by community input.

76.9% of parents reported that they currently use Branches, the free after care program, and would like to see it continue. This plan allows for the continuation of Branches as a free, aftercare program which will continue to offer enrichment activities. 74.4% of parents that responded to the survey agreed or strongly agreed to improve the outside environment to allow students to work outside when weather allows. In the plan, there are actions to make the outdoor environment more accessible to students and more comfortable in different types of weather. Making the outdoor environment accessible and comfortable is also consistent with our Safe Return to In Person Instruction & Continuity of Services plan. Staff recognized that some students need some extra tutoring to increase their classroom performance and test scores. 76% of parents answered yes or maybe to afterschool tutoring for their child. This plan allows for afterschool tutoring with certificated teachers that will be focused just on students who demonstrate the need and/or interest. 66.7% of families either participated in the 2021 Summer Enrichment Program or did not participate previously and would like their child to participate in 2022. The school will continue the program for Summer 2022, if staffing is available. This plan allows for those expenditures. The staff recognized that their students needed to continue the SEL work with the school psychologist that had begun during the 2020-21 school year. Learning cannot happen until social and emotional needs are met. This plan allows for the school psychologist to continue the work with entire classes and some individual and small group counseling.
